Introduction

We endeavour to promote employment security and conduct responsible workforce planning and restructuring when necessary. We see our unique attributes as an opportunity to create a positive work environment. We encourage collaboration to respond to global challenges as our story is written by our people and we lead by example. ISS invests in human capital and fosters professional and personal development. We respect one another's perspectives, seek ideas and inputs, and celebrate the unique perspectives and contributions that we each bring to ISS STOXX. While ours is a global company operating in offices across the globe, we respect local time zones and working hours as much as possible. We are committed to conducting our business in compliance with all applicable workplace health and safety laws and regulations as well as providing opportunities to our employees to improve their work-life balance. We respect and support all internationally recognized human rights as articulated in the United Nations Universal Declaration of Human Rights, as well as the core standards of the ILO Declaration on Fundamental Principles and Rights at Work; and are committed to avoiding complicity in any human rights abuses. We support and encourage the development of our people for a deeper understanding and responsiveness to ethical, social, and environmental issues as they relate to our business.

Environment

ISS aims to minimize our environmental footprint throughout our operations. We are committed to conducting our business in compliance with applicable environmental laws and regulations. Our approach to sustainability seeks to minimize our environmental impact, including by reducing CO₂ emissions and managing waste. We endeavor to increase energy from renewable sources in our own operations, reduce the carbon footprint of our data centers and business travel, and improve waste reduction and recycling.
